Thank you for requesting information on ISO Sprinkler Plan Review.

You may send your plan review information to us by email or you may send paper documents.

ISO requires you to send sprinkler drawings and hydraulic calculations for the location reviewed.

Materials information and cut-sheets are helpful but not required.

How to pay for sprinkler plan reviews:

If you already have an existing account with ISO we will invoice you after we have provided the service.

If we do not have an existing account for you please provide us with the following information so that we may set-up a new account: **Company name; Street address; Contact name; Contact phone number.**

Please note: ISO requires new account holders to pre-pay for their first ISO sprinkler plan review.

Pre-payments must be made by check or money order. After you pay for your first plan review if your account remains in good standing you will not be required to pre-pay and we will invoice you after any subsequent reviews. Credit card payments may then be made.

Please note: state sales tax will be applied to prices. If you choose not to add sales tax to your pre-payment, an invoice for the tax will be mailed to you at a later date.
