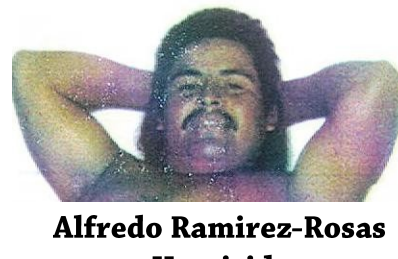


Tomball's Most Wanted

Alfredo Ramirez-Rosas: wanted for the brutal murder and sexual assault of a retired school teacher in 1993. Alfredo Ramirez-Rosa forcefully entered the victim's residence; sexually assaulting and murdering her by beating her to death with his fist. After committing the act of sexual assault and murder Alfredo bragged to his roommates and friends about what he had done then fled the surrounding area. Due to the nature of the crime and method of assault, ample quantities of DNA and evidence were recovered at the scene. An arrest warrant for Alfredo Ramirez-Rosas has been issued by the Harris County District Attorney's office and remains active. It is believed that the Alfredo Ramirez-Rosas has fled to his native country, Mexico, where he remains at large today.

UPDATE CAPTURED-March 2013, Suspect was captured in Mexico and is currently awaiting extradition to Texas.

Agustin Tamayo: wanted for the murder of his estranged wife's boyfriend in 2004. Agustin Tamayo forcefully entered the home of his estranged wife through her bedroom window at approximately 3:00 am assaulting the victim's (boyfriend) with a knife, ultimately causing the death of the victim. After committing the assault Agustin Tamayo left the scene returned to his place of employment, gathered his effects and fled the surrounding area to his native country Mexico. An arrest warrant has been filed with the Harris County District Attorney's office and remains active today.

Reyes Solis: wanted for the sexual assault of female victim. Reyes Solis threateningly removed the victim from the City of Tomball to a location inside of Harris County, where the crime of sexual assault took place.

UPDATE-CAPTURED: In March of 2009, suspect Reyes Solis was captured and placed in Harris County Jail with a bond set at \$50,000 for this crime.

Max Palma: wanted for Family Violence to his common law wife who is four months pregnant with their child. This incident occurred at the couples' apartment off of S. Cherry in early February of 2009. The suspect, who was intoxicated became angry and accused the victim of cheating on him so he choked the victim and then struck her in the face with his fist. No injuries were directed to the stomach of the victim but she stated she was in fear of her life by the suspect's aggressive actions. A warrant was issued for the arrest for the suspect who has fled the area.
